1. Preface

1.1 The following instructions are applicable for the Robert Bosch Automotive Aftermarket Division only and its facilities located in Atlanta GA, Oakbrook, IL, Ontario, CA, Summerville, SC

- 1.2 When <u>Bosch is responsible</u> for paying the transportation freight cost directly to the carrier, all vendor shipments must be shipped **Collect** and according to the instructions and definitions below.
- 1.3 Failure to comply will result in the excess transportation cost being debited back to the vendor.
- 1.4 It is imperative that you record the Bosch purchase order number(s) on the bill of lading. In addition, shipment packaging **must conform** to Robert Bosch LLC Automotive Aftermarket Division <u>External Supplier Packaging and Labeling Specifications</u>, which is posted at: https://www.bosch.com/company/supply-chain/information-for-business-partners/ Go to Logistics: Regulations and Standards section. Then Go to Regional regulations, as amended from time to time.

2. Definitions:

- 2.1 <u>Small Package</u> Any shipment **not** to exceed 150 lbs. (maximum combined length and girth of 130 inches and maximum length of 108 inches).
- 2.2 <u>Less Than Truckload</u> Any shipment exceeding 150 lbs. in weight but less than 10,000 lbs. and does not fill trailer to full visible capacity.
- 2.3 Full Visible Capacity Approximately 50% of trailer floor space utilized.
- 2.4 Truckload Any shipment which fills trailer to full visible capacity or exceeds 10,000 lbs.

3. Instructions:

- 3.1 <u>Small Package Shipments</u> as defined above UPS COLLECT. Vendor invoicing must not contain prepaid and added freight charges. (Do not insure / declare a value, unless approved by Bosch).
- 3.2 Use the following UPS account numbers when shipping to Bosch:

- 3.3 <u>LTL SHIPMENTS</u> as defined above. You should have received specific routing instructions from the TMC Overland team with details concerning your route specifications for material shipping. If not, please contact Richard McCoy, Transportation Specialist <u>Richard.mccoy@us.bosch.com</u> or 470-421-0289 to schedule the transportation for shipment(s).
- 3.4 <u>TRUCKLOAD SHIPMENTS</u> as defined above Any TL shipments that are managed by Bosch TMC will need to include the TMC Load # on the Bill of Lading.
- 3.5 AIR SHIPMENTS must be authorized by the Bosch Purchasing or Planning (Bosch affiliates) Department.
- 3.6 <u>HAZARDOUS MATERIALS</u> shipments must be in compliance with hazardous materials regulations.
